

WINNINGS PAYEE DESIGNATION & CONSENT FORM

Contestant Winnings — Split Payment Authorization

Split payment must be designated at the time of entry.

This signed form and a completed IRS Form W-9 from each payee are due within 48 hours of the win.

CONTESTANT WINNINGS POLICY

The following applies regardless of who paid the entry fees.

- **Default payment.** Unless otherwise designated, payouts and 1099s will be paid and issued directly to the winning contestant regardless of who owns the horse.
- **Private arrangements.** We are not responsible for private financial arrangements between horse owners, trainers, or lessors.
- **Split designation.** If designated with a signed consent by the contestant, up to two payees (individuals or entities) can be paid for any win. The designation may be split in any percentage.
- **Notice at entry.** Notification of a split designation must be made at the time of entry. The signed form from both parties and a W-9 form from each payee may be supplied within 48 hours of the win.
- **No retroactive changes.** If notification is not made at the time of entry and the payout has been paid to the contestant, there is no opportunity to retroactively change the payout.
- **Payment timing.** Payouts on split payment requested may be mailed to the designated recipient(s) within 5 days after the last day of the event.

- 4. This signed form and a completed W-9 from each payee must be received within 48 hours of the win. If they are not received on time, the entire payout will be paid, and the 1099 issued, to the winning contestant.
- 5. Event management is not responsible for, and is not a party to, any private financial arrangement between horse owners, trainers, lessors, or other parties.
- 6. Payouts will be mailed to the designated recipient(s) within 5 days after the last day of the event.
- 7. The information on this form is true and complete to the best of each signer’s knowledge.
